



2017 Stonewolf Annual Passes



Stonewolf Golf Club will have 2 Annual Pass offerings for 2017. **The PREMIUM Annual Pass will allow the pass holder to play 7 days a week at anytime.** **The SELECT Annual Pass allows the pass holder to play Monday-Friday (excluding holidays) at anytime and after 12:00 noon on Weekends & Holidays.** Both passes include unlimited greens fees, cart fees, and range balls for their applicable days of the 2017 calendar year and 14 day advance tee time reservation requests. In addition, all Stonewolf Club Pass Holders receive reciprocal privileges, on their applicable days, at the following Walters Golf Management golf courses: *Far Oaks Golf Club, Gateway National Golf Links, Normandie Golf Club, Emerald Greens Golf Club, Clinton Hill Golf Club, Union Hills Golf Club, The Prairies Golf Course, Woods Fort Golf Course, Eagle Knoll Golf Course, and Innsbrook Resort & Golf Club. Cart fees are required at a defined rate per round at reciprocal courses. All tee times for reciprocal courses **must** be made through the Stonewolf Golf Club Golf Shop and can be made 1 day in advance of the tee time. If your tee time reservation is not booked through the Stonewolf Golf Club Golf Shop, you will be charged the regular applicable rates at each facility. *Reciprocal rate will be \$17.50 at all participating golf clubs. **Stonewolf Golf Club reserves the right to close the course at any time for outside bookings or outings.**
