Liquor products MUST be donated and delivered by the manufacturer or one of its approved distributors of Stonewolf Golf Club.

Non-Alcoholic beverages will be charged except for bottled water. This includes sodas, sports drinks, juices, etc.

Corkage, icing, and handling fee of \$0.75 per can/unit will be charged on all product delivered.

The handling fee of any leftover product will be credited back to the event, but MUST be retained by Stonewolf Golf Club.

This product is for on-course use ONLY and may not be served after the round.

Glass bottle donations are NOT PERMITTED at any time.

BAR & BEVERAGE CART ATTENDANTS

All golf outings receive a bar & beverage cart attendant at no charge. Extra attendants will be \$100.00 per requested.

POLICIES, SERVICE CHARGES & MORE

Menu selections should be submitted to the Stonewolf no later than 30 days prior to the scheduled function. Guarantee of exact attendance for all banquet facilities must be made 15 days in advance and cannot be reduced. If Stonewolf receives no guarantee, Stonewolf will assume the guarantee to be the original number booked and that number will be the minimum charged. No food or beverage of any kind will be brought onto the premises.

According to State Law, service charges must also be taxed. A service charge of 22% and 10.35% state sales tax are added to all food and beverage items. Menus and pricing are subject to change on an annual basis. Please contact Stonewolf for further information.

Stonewolf Golf Club also reserves the right to refuse service to a guest at the discretion of Stonewolf staff. Stonewolf reserves the right to move a golf outing to another room or charge a fee for this room, depending on the guaranteed number of people in the party.
